Residential : Oakland County's only 24 hour emergency shelter exclusively for victims of domestic violence and sexual assault and their children. Counselor Advocates provide assistance with safety planning, employment, housing and medical needs. Residents have access to a communal kitchen and pantry. Counseling and other therapeutic activities are also available. Children and adults served in the fiscal year 2013 - 372
Crisis and Support Line: Oakland County's only 24 hour hotline dealing specifically with the issues of domestic violence and sexual assault. Specialists provide callers with crisis intervention, support, access to emergency shelter, etc. Total calls to the crisis line in fiscal year 2013 - 8,021 of which 4,610 were identified as crisis calls.

4b (Code:) (Expenses \$ 177,659 including grants of \$) (Revenue \$)

START: START (Safe Therapeutic Assault Response Team) provides around the clock medical attention, a forensic exam and emotional support to victims of sexual assault age 13 and older in a safe and supportive environment. For cases referred for prosecution, sexual assault nurse examiners provide expert testimony and advocates give victims support during court proceedings. Total clients served in the 2013 fiscal year - 148

Social Action: The Social Action program addresses the immediate safety needs of domestic and sexual violence victims through 24 hour advocacy and crisis intervention services. Advocates offer support, information and referrals for victims through all stages of criminal and civil proceedings including assistance with personal protection orders.
